## I. Payment Terms

The payment terms are \$460.00 consumer's down payment Cash or Check if the down payment is Cash the computer will be delivered within 72 hours. If the down payment is a check the computer cannot be delivered until the check clears or funds can be confirmed at the consumer's bank.

The final payment of \$360.00 will be due thirty days after the delivery date. Total cost of the New Desktop Computer will be \$820.00. After the final payment of \$360.00 is received full ownership of the New Desktop Computer will be transferred to the consumer.

## II. Purpose

The purpose is to own a High Quality, New Desktop Computer without long-term renting. Long-term renting contracts can result in over charges and unnecessary interest. This agreement will allow the consumer to own the product in the least about of time without any interest rates.

## III. Simple Talk Warranty

All Township Computer Sales & Services NEW Desktop Computers come with a three year warranty parts and labor. During the three year warranty the consumer will have to pay shipping cost to the vendor if a computer part needs replacement. **Please read** the entire **Simply Talk Warranty** because there are some things that is NOT covered in the New Computer Warranty.

## IV. Contract Agreement Termination

- 1) Township Computer Sales & Services will terminate this agreement for default, in whole if the final payment is not received three days after the final payment due date. After the agreements are terminated Township Computer Sales & Services will attempt to call and setup an appointment to pick up the desktop computer.
- 2) If there is no contact by phone in three attempts Township Computer Sales & Services will contact the Sheriff department to help with the collection of Township Computer Sales & Services desktop computer. Once the desktop computer is back in Township Computer Sales & Services possession, it will be inspected for damages.

Once the desktop has been inspected Township Computer Sales & Services will issue a refund out of the consumers down payment minus the days it was in the consumer's possession, minus any damages that are incurred while in the consumer's possession, and minus the \$45 hourly rate to re-install Windows to make Desktop Computer new again for resale.

3) If the consumer wants to terminate the contract due to hardship the contract will be terminated. An appointment will be setup to pick-up the computer. The computer will be inspected for damage. A refund will be issued out of the consumers down payment minus the days it was in the consumer's possession, minus any damages that are incurred while in the consumer's possession, and minus the \$45 hourly rate to re-install Windows to make Desktop Computer new again for resale.
